

DEALERS CHOICE AUTO AUCTION GENERAL POLICIES

If an Arbitration Issue is not specifically addressed below, DCAA will revert to NAAA Arbitration Policy

- Only licensed motor vehicle dealers or their representative(s) may do business.
- Retail customers are not allowed on auction premises.
- All vehicles must be offered for sale on the auction block.
- All vehicles must be paid for on sale day. No drafts.
- Unpaid Vehicle Fee: \$50 per vehicle over 2 weeks, \$25 per vehicle each additional week.
- It is the consignor's responsibility to check in the following with the office: Pull-Out Radios, Face Plates, Headphones, Navigation Discs.
- It is the responsibility of buyers to observe the announcement screen and be aware of any and all oral announcements made from the auction block.
- No vehicle is allowed to leave auction premises without a gate pass.
- Buyers are bound to all "IF" sales until 12:00 noon the next business day.
- Any mechanical arbitration must be initiated the night of the auction (including all IF's) – no next-day arbitrations unless a post-sale drive/inspection is purchased.
- Title Attached (TA) sales- Selling dealer has 21 days from sale date to supply title to the auction.
***Buyers- Do not sell or repair these vehicles until you receive the title.**
- Seller's Notice: Vehicles sold TA will be assessed a \$25 fee. Titles not produced in 21 days will be charged an additional \$25 late fee.

RIDE & DRIVE

Seller guarantees vehicle does not require mechanical parts in excess of \$500. Exclusions- Check Engine Light (CEL), visible defects, glass & tires. If CEL is on, no tranny code or timing code is present. Arbitrators' decision is final.

AUCTION GUARANTEE (AG)

Seller guarantees the following items: engine-no internal engine noise, transmission-vehicle shifts properly & has no excessive leaks, front & rear differential, block, crankshaft, main transfer case, and head/ head gasket (must fail pressure check & internal head gasket test). If an overheating announcement is made, vehicle is not eligible for head/head gasket arbitration. If Check Engine Light (CEL) is on, no tranny code or timing code is present. Vehicles sold with an AG are guaranteed by seller regardless of odometer reading or price. Vehicles must be able to be test driven to pass as AG. Arbitrators' decision is final.

NOT COVERED BY AUCTION GUARANTEE

Spare tires & jacks, air conditioners, windshield with visible cracks, torn drive axle boots, alternators, brakes & suspension, blow-by (engine), steering racks, backlash & clunk, shocks, struts, tie rod ends, ball joints, clutch, overheating (except head/head gasket), turbos, smoke, bad valves, cam, drive assembly, U & CV joints, wheel bearings.

*Any repairs less than \$500 mechanical parts on guaranteed unit

AS-IS

Buyer owns the Vehicle

MUST BE ANNOUNCED BEFORE SOLD

Title Attached (All States), Salvage or Previous Salvage Title (All States), Flood Damage, Frame Damage, Odometer Not Working, Damage Disclosure, Rebuilt Titles, Air Bag Disclosure, AutoCheck Mileage Discrepancies

BUYER HAS 7 BUSINESS DAYS TO ARBITRATE (IF NOT ANNOUNCED AT TIME OF SALE)

Flood Vehicles, Frame Damage& Cracked Blocks. Arbitrators' decision is final.
